Dear Sir,

I am writing this letter to say that I am a very concerned citizen about people who are both falsely imprisoned and also about criminals who should be imprisoned and are not. I want to say that I appreciate the difficult task that you and others in law enforcement must face in deciding on the outcome of parole hearings.

I am also writing you today specifically regarding a friend I have known for close to 20 years, PF Lazor. He has been imprisoned for 16 years in what is clearly a case of self-defense. He has no prior criminal record of any kind.

Because the court system is so burdened and overloaded, my friend has been unable to get a new trial or get paroled. I am shocked that a person who is in no way a "criminal type" is being kept in prison at the taxpayers expense. How can this be?

The reason given for PF Lazor's incarceration is that someone broke into his home by kicking his door down, came at him with a knife, and in self defense he shot this person.

I have known PF in both a professional setting, and as a friend. I have never known him to be anything but kind, caring, intelligent, creative and supportive person. Surely this kind of person should be contributing to society with his creativity. Prisons are overcrowded. From everything I know, keeping someone falsely imprisoned is not only a crime in itself but not very practical. (Even if it was not self-defense, how can any court system in the world justify, 16 years for a person with no prior criminal history?)

You must get many letters claiming innocence, etc. from many different family and friends of many different prisoners. You may say as you read these letters "yeah, yeah, yeah, yeah, l've heard this all before....." However I hope you will have the time to consider this letter in a fresh light and with a new spirit and with caring eyes.

Apparently he has been given many outright false RVRs. He has tried to get these RVRs taken to court to get overturned, and been denied this opportunity. True or false, how can one be denied parole because of RVR's or any other reason when one is falsely imprisoned in the first place?

If you were to meet PF in the prison setting you would immediately notice that he is different. Different than any other prisoner you have possibly ever met. You would be struck by this difference. What is this difference? Clearly he does not fit in. Clearly he is not a criminal. You would be hard pressed to find any evidence of that in him.

Parole is long overdue. I sincerely believe that his case **more** than deserves a fair new look. I am sure that you will find more than enough evidence to support parole.
