- I, Neil Alan Scott, a natural born free Citizen of the State of Towa, do hereby affirm that the following statements are true and correct to the best of my knowledge and belief:
- 1. My name is as shown above, as are my address and professions. My family and I have been inhabitants of this City since 1974; and it's been my pleasure to serve with our City Hall personnel and others in advisory capacities, including five years on its Citizens' Advisory Committee for Energy etc. Our reputation in this community is excellent.
- 2. My wife and I have known Mr. PF Lazor for over four years, following his communicating after reading one of my articles in a newspaper. During this time it's been our privilege to assist him insofar as possible with his day-to-day needs; which have included modest funds, postage, communications and two in-person visits during a special trip to see him and his sister from Michigan during Thanksgiving week of 1987 in Atascadero, California. During these years it's been possible to quite thoroughly study the facts of his unfortunate case in depth.
- 3. Although having M.D.-affirmed acute dietary problems since birth, PF Lazor has consistently been to us an intelligent honest responsible individual whom we have every reason to respect immensely. Having worked with countless others as a professional counselor, I believe that the best of people might have difficulties with the unusual stresses and pressure of prison existence; but he's held up well. An example occurred in 1987 when we'd assisted in financing a Polygraph Examination, to prove that he was innocent of a false charge. Attorney John Cornelius and the Polygrapher Bob Stevenson had driven a long way for this, were kept waiting for six hours at the prison before seeing PF Lazor, and it was he who calmed them.
- 4. After we met with PF in 1987, I agreed that he could store some of his boxes of files here, which he authorized us to study as well. These involve not only his life to date, but also include over 70 personal letters with perjury jurats from his pre-trial witnesses in 1983-84 - attesting to his business success, honesty, hobbies, community and church services etc. - but which were not allowed in evidence.
- 5. With the foregoing facts, I have to conclude that PF Lazor is an individual who can once again be a substantial asset to his community; with many fellow Citizens eager to assist with us in his happiness and success. Please let justice be done.
