I have known Mr. Lazor as a patient since 1979 because of his symptoms of fatigue, spells (evidently related to blood sugar instability), insomnia, fibromyalgia and multiple allergies and environmental over-sensitivities. In retrospect it is apparent that he is intolerant of both milk (lactose intolerance) and wheat (gltuen intolerance). I mention these medical facts because they have adversely affected his relationships with prison authorities.

I hope this has not confused the Board regarding his eligibility for parole. In my personal visit to Mr. Lazor and my occasional correspondence with him, I am amazed at the grace, intelligence and fortitude with which he has endured his prison years. He was a charming and promising young man when he first came to me for medical help. He seems now to be sadder and wiser-not bitter. Frankly, I admire him.

I have read through his appeal records again because my mind boggles at the seeming injustice that has clouded this case from the outset. I honestly believe that this man was convicted mostly because he lacked the funds to obtain adequate counsel. The records point to self defense at the crime scene and poor defense in the court-room.

It is painful to see a good man kept in prison longer than necessary. If there is anything I can do to help you understand Mr. Lazor, to be accurate and fair to him and society, I will consider it my civic duty. His life history is reassuringly free of delinquency and violence. His positive character has been attested by scores of friends. His ex-boss vouches for him as a successful person. He continues to produce quality music while in prison. At the risk of sounding corny, I beg you: FREE P. F. LAZOR–NOW.
